Document Requirements

Due to varying circumstances, the below list of document requirements may not apply to all families.

2015 1040 Tax Return

- First and Second page of the Federal 1040 tax forms from the adult applying or renewing the scholarship. The second page of the 1040 must be signed.
- Number of Exemptions on the 1040 tax forms must correspond to the number listed as the household on the application/requalification forms.
- If the child is not documented as a dependent by the adult applying for the scholarship, we also need the first and second page of the Federal 1040 tax forms from the person claiming the child/ren. The second page of the 1040 must be signed. Both incomes and household sized should be combined and reported on the application forms.
- **Schedule C and/or Schedule E (If you have a business or rental property, you must submit this portion of your income tax)**

If you have misplaced your tax forms, contact the Internal Revenue Service at 1-800-908-9946 and request a transcript

2015 Paystub

- Most recent 2016 paystub from your employer(s).

Unemployment/Worker's Compensation

- Official Unemployment letter from the Department of Labor.
- Worker's Compensation award letter.

If you have misplaced your statement, contact The Department of Labor at 1-888-209-8124

Public Assistance/Food Stamps

- Budget Letter showing amounts and names of all household members.
- Public Assistance (Cash Grant) and or Food Stamp award notice showing names in household.

Social Security

- SSA-1099 for all family members receiving benefits.
- SSI statements/letters for all family members receiving benefits.

Child Support/Alimony

- Court ordered legal documents showing awarded amount.
- Notarized letter from the person paying support stating amount.

Adoption Subsidy

- Official letter stating the amount.

Foster Care

- Official letter from the Aid to Families with Dependent Children-Foster Care Program (AFDC-FC).

Other Financial Sources

If a parent does not file taxes, an employment verification letter is needed. The **notarized** letter must consist of the following:

- Name of the employer and business (company letterhead is sufficient)
 - Employee position
 - Employee hours
 - Annual salary amount
 - Copy of recent pay check
 - Employer signature and must be dated
- **Letter must be an original and on company letterhead.*
- Family members offering financial assistance-notarized letter stating annual amount.
 - Friends offering financial assistance-notarized letter stating annual amount.
